

COME OUT OF JUDEO-CHRISTIANITY AND MULTICULTURALISM by Pastor Dave Barley

I will try to word the following as nicely as I can, but the reality of our present national situation is that the time for pretending our nation can keep going in a coexist multicultural format must stop. We are being lied to in and through Judeo-Christian wording and concepts that are pure deception. We often hear, "well I don't want to rock the boat or ruffle anyone's feathers," and this in many ways has been the problem. There is probably no greater illustration of the present situation we face as a people and as a nation than the lie of Judeo-Christianity which I shall try to make abundantly clear to you in this article. Let us begin with the race issue.

The Word of God absolutely deals with and pertains to race, that is, the White, Anglo-Saxon, Scandinavian, Germanic, and kindred people. In today's era of multiculturalism comfortability, to claim that the Bible is not multicultural and does not endorse race mixing, pluralism, homosexuality, paganism, open borders, or basically any form of antinomianism (meaning any form of anti-Bible law), would appear insane and woefully out of date. Well, though it is woefully out of date and politically-incorrect to believe that the Bible teaches against such things, it certainly does. This must be thoroughly understood, believed, and taught with a greater fervor.

THE WORD "TRIBE"

Christians, we have a Biblical duty to stand for Bible Truth, which

includes having a Biblical Israelite tribal family cohesiveness. Remember we originally were twelve-tribes of Adamic Israelites. The word "tribe" in Hebrew means: "rod, staff, or tribe". ⁹ Not according to the covenant that I made with their fathers in the day when I took them by the hand to lead them out of the land of Egypt; because they continued not in my covenant, and I regarded them not, saith the Lord.

¹⁰ For this is the covenant that I will make with the house of Israel after those days, saith the Lord; I will put my laws into their mind, and write them in their hearts: and I will be to them a God, and they shall be to me a people:

First of all this may be a point understood by most of the readers, but the only people being addressed in these verses of the New Covenant are the people of Israel. Secondly, note that God's Law and His Covenant people go hand in hand. In other words, and I want you to understand this, that the people of Israel and the Laws of God go together. If you could somehow remove God's Covenant people Israel, you in essence would also be removing God's Laws. We see this visibly in the world among us, that wherever God's people (White Israelite leadership) is removed, the very semblance or measure, no matter how watered down it may be, of God's Divine Principles will not last very long.

Righteousness exalts a nation, which means, the righteousness of

God's law is how things are to be defined and resolved. Righteousness is not produced from man's carnal-mind or thoughts, it is the result of man (Adamic-Covenant-Israelite man) obeying the righteous principles of God's Word.

Adamic Caucasian Covenant Israelite man is the God ordained, purposed, covenanted people to carry out national and even international "garden of Eden" restoration through the leading of the Holy Spirit direction of King Jesus Christ and His New Covenant. In other words, God Almighty did not make a mistake in choosing Adamic Israel to be His Covenant people. Hosea 6:1-6

¹ Come, and let us return unto the LORD: for he hath torn, and he will heal us; he hath smitten, and he will bind us up.

² After two days will he revive us: in the third day he will raise us up, and we shall live in his sight.

³ Then shall we know, if we follow on to know the LORD: his going forth is prepared as the morning; and he shall come unto us as the rain, as the latter and former rain unto the earth.

⁴ O Ephraim (the Northern House of Israel), what shall I do unto thee? O Judah (the Southern Kingdom of Judah), what shall I do unto thee? for your goodness is as a morning cloud, and as the early dew it goeth away.

⁵ Therefore have I hewed them by the prophets; I have slain them by the words of my mouth: and thy judgments are as the light that goeth forth.

⁶ For I desired mercy, and not sacrifice; and <u>the</u> <u>knowledge of God</u> more than burnt offerings.

What is God's Purpose for His Covenant People? To teach and impart God knowledge as verse 6 declares, but not to pagan heathen people or their territories. The whole book of Hosea is about God's relationship with Israel. It's about **Biblical HOPE**, that Israel, after their period of judgment, would again know that they were God's Covenant People and that He loves them.

God Knowledge is not for awakening the world, but the world of Adamic Israel. Does anyone really think for instance that we can go over to the dark areas of Africa, impart God's Word to them, and they or the Chinese, or the Hindus will ever fulfill what God has called His Adamic Israel people to do? Only in Judeo-Christianity or Spiritual-Israel fantasy land.

JONES-TOWN NIGHTMARE

The reason Israel is not awakening is because they are being lied to and they are still sipping on the Jones-town Kool-Aid. Do you remember the sad but true story of a Dr. Jones? Jim Jones was a Spiritual-Israel proponent. Quite literally, and the history of Jonestown will verify the fact that Jim Jones was originally seen helping minorities and working against racism. A movie was made about this tragedy back in the 80's called *Guyana Tragedy: The Story of Jim Jones*. The tragedy is about how Jim Jones rose to power among his followers, moving his church to the Philippines, I'm sorry, I meant, from San Francisco to Guyana, where eventually, he presided over the mass murder/suicide of hundreds of his followers in the drinking of poisoned Kool-Aid. Jim Jones was a huge proponent of multiculturalism, and it is the real Kool-Aid he was feeding his followers.

THE RESULT OF MULTICULTURALSIM

The truth presented in **Hebrews 8:8-10**, is that God's Covenant Israel people and the Laws of God are both deemed and redeemed for the Divine Purpose of Restoration. If you separate the Law from

the Covenant People you have no restoration. America, Britain, Canada, Europe, Australia, and other Caucasian kindred nations do not and cannot have restoration without both the Covenant People (Israel) and the Laws of God upon their heart or mind. If you try to remove and replace God's people with another race of people, and/or mixed multitudes trying to have restorative results, you are violating God's Old and New Covenant Purposes and His Laws of separation. The results will be Judeo-Christian multiculturalism, where His Law is diminished and His Word perverted.

When the Word of God says, "*Righteousness exalteth a nation: but sin is a reproach to any people.*" Proverbs 14:34 The word "*people*" literally means "*nation*" and its context clearly appoints the word "*nation*" to Israel. The Word of God does not happenstancely speak of Israel for they are the directed purpose of God's Covenant Word. No other people are the directed purpose of God's Word.

THE JEWISH DILEMNA

Judeo-Christianity would have Christians falsely directed to the Jews as being God's Covenant People, and that if you bless the Jews (the Edomites and Khazars) as John Hagee and his cohorts admonish people to do, then you are following *"the great commission"*. This of course is patently false, and without getting into great detail, it is false simply based upon the fact that Christians are to have no fellowship with antichristism (Judaism/Talmudism).

THE GREAT COMMISSION

What is the so called great commission? It would be best described in the following verses:

Acts 3:25-26

²⁵ Ye are the children of the prophets, and of the covenant which God made with our fathers, saying unto Abraham, <u>And in thy seed shall all the kindreds of the earth be blessed.</u>

²⁶ <u>Unto you first God, having raised up his Son Jesus,</u>

sent him to bless you, in turning away every one of you from his iniquities.

Many of you will no doubt notice the words "Unto you first", believing this is a good opportunity to call my attention to your understanding that this would mean "unto Israel first and then the rest of the world." But this is not the correct interpretation at all. "Unto you first" simply means unto you Jews (or Judeans) has He (Jesus) come first unto, then unto the rest of the dispersion of the House of Israel. The very people of the Abrahamic Covenant, the very people God Almighty gave His laws unto, the very people Jesus Christ came to redeem and turn away from their iniquities, for it is unto them He hath given His laws and therefore the burden of sin is upon Israel. The laws of God were not given in a marriage Covenant unto any other people.

Thus when we read in verse 26, "...every one of you (Israelites) from his iniquities", and verse 25 states, "...in thy seed shall all the kindred of the earth be blessed", does not mean all races of the earth shall be blessed. It means all thy kindred of the earth shall be blessed. The word "kindred" is the Greek word "partria" which literally means "family, kindred, or lineage." As much missionary work there has been over the centuries to all kinds of people, when the White man leaves, his Christian faith leaves with him. The blessing is and has mostly been upon White Adamic kindred people and nations.

Can you truly say lasting blessings have been upon Africa, India, Mexico, South America, China, and so forth, apart from pockets of corrupt banking-money which is superficial, but more pertinent to our conversation, Christianity, that generally does not last when the White man and his missionary money leaves? Think about Ferguson, or other similar areas, then think about dark Africa. Where would they be without a certain amount of White leadership or control? Certainly the Obama administration is pouring money into Africa, and you can point to areas of "prosperity," however, this is not Christianity, and without the White man and the Bible, there will be sinking sand foundations. You may say, why that's "racist thinking" to which I would respond, "Yes, you are correct."

Some of you may say, "Pastor Barley, you seem to have changed some of your previous Biblical views," to which I would respond, "Yes, I have changed a few of my formally wrong opinions, because they were just that, opinions. What I did was stop drinking the jones-town type of Kool-Aid, and started reading and drinking the Word of God for what it truly does declare."

THE TREE OF THE KNOWLEDGE OF GOOD AND EVIL IS THE SAME AS JUDEO-CHRISTIANITY

Which brings me to my next subject, Judeo-Christianity and the tree of the knowledge of good and evil. God told Adam and Eve not to partake of the tree of the knowledge of good and evil. They, of course, did not listen and the fall of Adamic man occurred. That fall was the result of disobedience is without question, but the understanding of what this forbidden tree is, that is the question. Matthew 7:13-23

¹³ Enter ye in at the strait gate: for wide is the gate, and broad is the way, that leadeth to destruction, and many there be which go in thereat:

¹⁴ Because strait is the gate, and narrow is the way, which leadeth unto life, and few there be that find it.

¹⁵ Beware of false prophets, which come to you in sheep's clothing, but inwardly they are ravening wolves.

¹⁶ Ye shall know them by their fruits. Do men gather grapes of thorns, or figs of thistles?

¹⁷ Even so every good tree bringeth forth good fruit; but a corrupt tree bringeth forth evil fruit.

¹⁸ A good tree cannot bring forth evil fruit, neither can a corrupt tree bring forth good fruit.

¹⁹ Every tree that bringeth not forth good fruit is hewn down, and cast into the fire.

²⁰ Wherefore by their fruits ye shall know them.

²¹ Not every one that saith unto me, Lord, Lord, shall enter into the kingdom of heaven; but he that doeth the will of my Father which is in heaven.

²² Many will say to me in that day, Lord, Lord, have we not prophesied in thy name? and in thy name have cast out devils? and in thy name done many wonderful works?

²³ And then will I profess unto them, I never knew you: depart from me, ye that work iniquity.


They're amnesiacs when it comes to rights of retribution by the Arab boy,

Christian Economics

The entire theory of Christian economics is very simple. In fact, it can be completely summed up in a single sentence:

THOU SHALL NOT STEAL

This prohibition is, in total, Christian economics. All the stacks of immense texts by the likes of David Ricardo, Adam Smith, Ludwig Von Mises, Friedrich Hayek, and Milton Friedman are unnecessary. Just don't steal what another has produced. In all that you do, don't steal! This rule is sufficient for man's economic affairs. If the works of man have become so complicated that they appear to have outstripped this simple principle, it is not God who has become irrelevant or obsolete to man's affairs. It is man who has rendered himself irrelevant to God and to mankind as well. God's Law is also a limit to man's tendency toward social complexity to conceal his sins.

The reason non-Christian economics is so complex, so esoteric, and elitist; the reason why there exists libraries of dense volumes by the likes of Ricardo, Smith, von Mises, Hayek, and Friedman, is for no other reason than to get around God's Law: Thou Shall Not Steal.

Man has spent the last several thousand years – since the Commandments were first delivered – putting all of his economic efforts into figuring out ways to either nullify God's Law or exempt himself from part of it, and still be "of the People of God." This subversion is the essence and soul of non-Christian economics. Properly speaking, since it is God alone who defines terms of meaning, man's economic theories are actually theories of non-economics or anti-economics, theories to subvert economics.

If economics is – as God defines it – concerned with the unbreachable link between earning and ownership, then man's anti-economics are concerned solely with theft and

dispossession; and of course, the disguising of this theft and dispossession as their opposites. Getting away with the crime is as important as the crime itself. Think of it like this: God's Law is the bottom line. There is no rule more basic, God's Law is the only Law one can appeal to. The two sides of God's Law - the prohibition and the act prohibited – are absolute.

Complexity never issues from God's prohibition. The Law remains as simple as it always is because man in his sin is simple, though he likes to imagine himself sophisticated and complicated. Complexity always issues on the violation side of the Law, but this complexity is merely a hustle intended to shroud the same old simple sins in confusion. But the preaching of God's Law exposes and reigns man's pretensions back in and under conviction.

Notice how in modern times in the most expansive sense of this epoch – say from the renaissance to 1900 – the agenda of scholarship has been to wrest disciples of human endeavor from the domain of Christian theology; from being subcategories of theology, to become autonomous and neutral categories unto themselves.

The explicit agenda was to remove all fields of life from under the sovereign authority of the God of the Bible. Even scholarship itself revolted against the monastery and seminary, and set itself up as independent secular institutions. Since the Renaissance, the mainstream of Western Civilization has been a direct war against the Kingship of Christ. Economics is one of these fields that was once a subcategory of Christian theology and related directly to God's authority and Law.

The work of Adam Smith and others was concerned with removing economics – man's medium of social organization and behavior – from under Christ's jurisdiction and making man a god of himself in his social live, but, of course, with the provision that Christ's name is invoked occasionally for the sake of deniability.

Those Ungovernable Colonists

Our founding fathers knew when to build, and when to fight — and



what to build, and what to fight.

The American colonies must have been an unruly place, full as they were of religious fanatics and

slave traders, second sons and fortune hunters, criminals and former political prisoners, and all manner of people in between. The first settlements hugged the coast, where one set of adventurers looked seaward while another looked to the interior wilderness. It was, in retrospect, almost inevitable that North America would quickly become the wealthiest place in the world by the 17th century.

Why? Because those seditionists, fanatics, and gamblers were impossible to rule. While we are counting our blessings this Thanksgiving, let's not forget to count that one: Our ancestors did not much like being told what to do, and we — and the world — are immeasurably richer and happier for that.

Edmund Burke called the Crown's attitude toward the colonies "wise and salutary neglect," but it was as much pragmatism as it was policy. There were many colonies and colonists, they were not of a uniformly obedient type, they were far away and, most important, they were extraordinarily productive. By the latter half of the 18th century, there were more iron forges in the American colonies than in Britain, the colonies were exporting millions of barrels of flour and tons of other agriculture products, and one out of three ships in the British merchant fleet was American-built. The economy was booming, and most of the population still lived in rural or semi-rural areas, far from the amusements of urban life, which may explain why the ratio of colonists to subjects back in England went from 1:20 to 1:3 in the course of just a few decades.

One of the reasons why the Industrial Revolution — which is to say, modern civilization — first rumbled to life in Britain rather than in Spain or Germany was the secret unruliness of the English, seemingly one of the world's ruliest peoples. A combination of happy historical accidents and cultural predisposition meant that Englishmen were relatively free to pursue their own economic ends; even in the late medieval period, England did not have anything so strict as the German guild system or serfdom as intensely enforced as French villeinage. The American colonists regularly flouted laws purporting to regulate trade and manufacturing, and the Crown wisely looked the other way. (Until it didn't, at which point it got a fight and lost.)

The division of labor is the essence of civilization, the underlying source of practically every good thing about the material conditions of the modern world. It is why civilized countries do not have famine any more, why we are surrounded by technological wonders, why things like air travel and mobile phones go from being restricted to millionaires to being ho-hum over a short course of years. Most of the technological ingredients for the Industrial Revolution had been in place not only in Britain but in Spain, France, Italy, etc., for years. But British subjects and American colonists had the opportunity and the inclination to begin a finer and more robust division of labor than did their European counterparts. They were just a little bit more free and a little bit more determined to be free — and that little bit made an incalculable difference, not only to them, but to the world.

They built something remarkable. And the idiot children of the Left are today cheering those who would **literally burn it**

down, in Ferguson and elsewhere.

I am generally inclined toward outbreaks of orneriness, whether in Nevada or in Missouri. If the people of Ferguson believe that they are misgoverned, that their police are a problem, that the usual forms of legal and political redress have failed them, then, by all means, shake the foundations. And there may have been about five minutes at the beginning when that's what this was about. The crowd in Ferguson is now very little more than a <u>lynch mob</u>. Maybe I should be ashamed of it, but there's a little part of my heart that would leap at the sight of Americans setting fire to a tax office. But setting fire to an Autozone? Pathetic.

There's a famous meme that made the rounds during Occupy Wall Street, with a hippie-dirtbag protester labeled "Wants More Government" and menacing police in riot gear closing down on him labeled "More Government." Those of us who want less government do not want only that: We want what flourishes when men are left free to pursue their own ends. The Left, on the other hand, takes every instance of unhappiness as an argument for more government including bad government. Our founding fathers knew when to build, and when to fight. More importantly, they knew what to build, and what to fight.

The most shocking act of nonconformity in Ferguson, the boldest declaration of independence, would be starting a business rather than burning one.

Legal Fight Starts Over SNP 'State Guardian for Every Child'

A judicial review starts of legislation assigning every child in Scotland a state-employed 'named person' amid claims it breaches parents' human rights to raise their children.

A legal fight in Scotland's highest civil court starts today to block an SNP plan to assign every child a

state guardian over claims it rides roughshod over parents' rights to raise their children how they see fit.

Judge Lord Pentland is to examine the lawfulness of the measure, contained in the Children and Young People (Scotland) Act, which assigns a "named" person such as a teacher or health visitor to anyone aged under 18.

The No To Named Persons (NO2NP) campaign group has brought the action, arguing that SNP ministers exceeded their powers and breached both data protection laws and the European Convention on Human Rights.

Aidan O'Neill, a senior human rights lawyer, is expected to argue during the four-day judicial review at the Court of Session that the legislation represents an "unjustified interference" into private and family life.

The campaign warned last night that the standard of proof for intervention had been reduced to the extent that the state could gain "unbridled access to every living room in the land" and warned parents' role could be reduced to that of "assistant" to the state.

Among the scenarios it said could arise would be the named person giving a 13-year-old girl sex education materials that her parents have withheld on the grounds they think them unsuitable. Although the scheme is not supposed to have officially come into force yet, it said James and Rhianwen McIntosh, of Bonnybridge, near Falkirk, were informed in April this year that their four children had been assigned named persons.

The campaign said they were told the NHS wrote to them saying their children's medical records would be passed to the named persons, who would also be informed if an appointment was missed.

Speaking on the eve of the case coming to court, Colin Hart, NO2NP's spokesman, said: *"This is all about the fight to save families. Enormous issues are at stake."*

"What could be more important than the rights of mums and dads to bring up their children how they see fit, not being dictated to by the heavy-hand of meddling and interfering politicians and their army of taxpayer-funded state monitors?"

He added: "We are making a stand for their independent rights to enjoy a private family life in their own homes with their own children."

The campaign has raised £50,000 from more than 70 individuals and groups to fight the case and is being spearheaded by the Christian Institute, Charity Christian Action Research and Education, the Family Education Trust and Tymes Trust, which represents young ME sufferers and their families.

Under the Act, which was passed by MSPs in February and is due to come into force in 2016, the NHS will appoint a health worker to act as a "named person" for every child until the age of five.

The Importance of One's Lineal Ancestry

Introduction: I have been a student of the Bible for over forty years. I have been interested in genealogy, presently, for almost twenty years. And, fairly recently, due to the relatively inexpensive availability of genetic testing, I have taken an active interest in the human genome project, and, more specifically, how one particular "marker" can be related to the other topics I will be mentioning. Therefore, it shall be the purpose of this article to explain how many of these topics are interrelated to each other and, subsequently, present some rather startling conclusions that I have drawn as a result of discoveries I have made concerning what I view as genetic proof of the existence of an Adamic Race.

Some Basic Definitions: Before I begin, I need to present some information relating to several standard, generally accepted, definitions for a few key terms and concepts. These are as follows:

<u>Lineal Ancestry</u> - Lineal ancestry revolves around all to whom one is *directly* descended from. Thus, a lineal descendant, in the usage you will find in this article, refers to a blood relative in the direct line of descent - the children, grandchildren, greatgrandchildren, etc., of one specific person.

<u>Collateral Ancestry</u> - Collateral ancestry refers to everyone who is blood related, but not in your direct line of descent. Examples would include an aunt, uncle, or a cousin. And, most certainly, collateral ancestry would include siblings. But, it is important to note that while a brother or sister may have the exact same lineal ancestry as you do, they are not considered lineal ancestors in relation to you. They are collateral ancestors.

<u>Genetialogy</u> - A recently created word (a combination of genetics and genealogy) which is used to describe tracing one's

genealogy by using the science of genetics (DNA testing specifically), and even more specifically, DNA testing for common genetic markers.

<u>Most Recent Common Ancestor (MRCA)</u> - This is a term used frequently in genetialogy. While seldom actually located, one's most recent common ancestor is a real term. This person actually existed and could possibly be found (theoretically) in the lineal ancestry of any two individuals (either male or female.) It refers to the one common ancestor both individuals (genetically linked) must have had as has been revealed by genetic testing. It is important to note that the number of generations between an MRCA and the two individuals who are genetically related may not be the same.

<u>Most Distant Common Ancestor (MDCA)</u> - The one individual who is the single individual responsible for the existence of an entire lineal descent group. In the instance discussed in this article, it represents a man named Adam, the primogenitor, of the Adamic Race.

<u>Descent Groups</u> - Descent groups are composed of the lineal descendants of a common ancestor.

<u>Unilineal Descent</u> - Unilineal descent is either patrilineal or matrilineal. In other words, one's direct lineage traced backwards on either the male side or the female side using either genealogy or genetic testing. If patrilineal, it is always one's father, his father, and his father. Quite simply, father grandfather, g-grandfather. These days, all who had the same surname, excluding uncles, siblings, etc. With matrilineage, it is the same, but of course, surnames would be different. In the article that follows, the author will suggest a genetic test that should reveal Unilineal descendancy from the Adam of the Bible for those who belong to a specific Haplogroup.

Haplogroup - Please reference the discussion in the text

presented below.

<u>DNA Testing</u> - One can find a whole lot of info about DNA testing at www.familytreeDNA.com.

This Is What This Author Intends to Demonstrate: In this article I intend to show that certain male individuals presently alive on this planet, now have the capability, using genetic testing, to determine if they are a lineal descendant of an individual mentioned in Scripture known as Adom or Adam. Additionally, I intend to show, if my premise is true, that Adam can be established as the Most Common Recent Ancestor for millions of individuals presently living on this planet by applying the rules of how one's lineal ancestry is established using DNA, so that we can begin to understand who our true "brothers" (genetically speaking) and "sisters" are.

Disclaimer: While the concept of different races is definitely considered in the article you are about to read, nothing should be interpreted as attempting to suggest or establish one race is above, superior to, lessor than, or, in any way, different than any other race, excepting in their male Y chromosomal structure, is suggested or even implied. It is the sole purpose of this author to establish a scientific basis by which the topic of race may be more thoroughly investigated by others.

The Article Itself Begins Here: First, some technical stuff: O.K. It has to happen. I will make it as simple as possible. Certain, now well established scientific understandings about genetics have to be introduced. Otherwise, this article will be meaningless to most who read it.

Since about 2002, when the availability of genetic testing became readily available to most anyone with a couple of hundred bucks to *"invest,"* genetialogy has exploded. I hope to be one of the first to expand some of these scientific understandings to include discussions of race and, especially, the Adamic Race.

To start with, let me first get real technical. I promise I won't dwell on it. Let's start with Haplogroups. A haplogroup, for all intents and purposes, is simply the assignment of a name (actually a repeating set of letters and numbers) to individuals, who through genetic testing, have been determined to have the same genetic markers. The Haplogroup I will be focusing on in this paper is identified as R1a, or sometimes, R1a1. I believe this is the haplogroup that identifies all of the male descendants of a being referred to in the Bible as Adam.

Now I need to quote, briefly from a rather technical article titled "A Nomenclature System for the Tree of Human Y-Chromosomal Binary Haplogroups" published in "Genome Research" in February of 2002. ". . . the emergence of several unrelated and nonsystematic nomenclatures for Y-chromosomal binary haplogroups is an increasing source of confusion." [continuing] "To resolve this issue . . . a representative set of examples, 74 of which were males [taken from and identified as being the sum total of all known basic types of Y DNA] from the Y Chromosome Consortium cell line repository." Got it?

Overly simplified, what the above states is this: There are only 74 different male lineages we can be looking at. (Think 74 races - maybe even the *"seventy nations?"* Genesis 10-11) Of these 74 different male lines, I am strongly suggesting, but can not definitively prove, that just one of these (the lineal ancestry identified as R1a... haplogroup) is representative of a fairly large number of individuals (think the promises to Abraham) who should *all be considered as <u>direct</u> descendants of Adam and Eve.*

Secondly, and very importantly, it is necessary for the reader of this article to be exposed to what is technically known as recombinant and non-recombinant DNA. Recombinant DNA is the stuff scientists like to mess with to create the likes of GMO foods, and other stuff like that. Not good, in my opinion. These scientists

are now boasting that that will be able to alter human genes (or maybe even already have) in the very near future.

But, here is a partial quote from another technical article: "There is no recombination between the X and most of the Y chromosome [the sex chromosomes.] Genes on the part of the Y chromosome that does [sic] not recombine <u>will be</u> <u>passed from father to son, down the paternal lineage</u>, and will never be present in females." [Emphasis by this author]

So, what the above suggests is that the male Y chromosome of a direct descendant of Adam is identical with the Y chromosome that Adam had. I feel it is much more than simply a suggestion. I take it as a fact, a soon to be accepted fact, I hope.

That's pretty profound and bears repeating. If I am a direct descendant of a man known in Scripture as Adam, (which I am certain that I am) then my Y chromosome is IDENTICAL with the Y chromosome that Adam possessed! So simple and yet so profound in what it means!

And, this statement, combined with the present day capability for most anyone to be genetically tested, allows for some powerful arguments about who all are the real descendants of Adam, or, as Pastor David Barley introduced me to who all are a part of the Adamic Race.

How This All Started: I had been studying my own genealogy for over twenty years by the time genetic testing became available. Using the on-line service provided by FamilyTreeDNA, I had my DNA tested for over 67 markers in four separate purchases. I did this over a period of time because when these services first became available, they were a bit "pricey" in my estimation. Now days, prices for such testing have dropped considerably and they are much more reasonably priced and certainly more readily available as the number of testing services has expanded greatly. Anyway, about three years ago I found myself an in-patient at Huron Medical Center, in Bad Axe, Michigan, having been admitted for heart related problems. Over the course of one week-end when the regular "docs" took time off, I was attended to by a female doctor, a Dr. McComb, who was covering for the absent docs. Being as it was a small hospital, and she wasn't terribly busy, I struck up a conversation with her about my Y chromosome DNA that I had recently had tested.

I told her I was classed in Haplogroup R1a1 . . . to which she responded, seemingly surprised, "You aren't Jewish, are you? You certainly don't look Jewish."

To which I responded, "Oh, no, not even close!"

Well, I thought about this for some time before I came to the realization that Edomite Jews are descended from Esau, the brother of Jacob. And, if that were true, then I quickly realized that my Y chromosome would be identical to the Y chromosomes had by all genuine Edomite Jews.

Wow! What a realization!

I started to think further about all the male ancestries recorded in the Bible in such comprehensive detail. But, I never really, until just recently, made the connection all the way back to Adam, and, even more significantly, recognized what it actually meant.

A King's DNA Becomes Suspect: Recently, in the major media, there have been a number of stories about a long since deceased British King (King Richard III) whose bones were examined for DNA. And, it was discovered that the DNA of his presumed male offspring did not match his. So, now that someone other than myself has broached the subject of how male DNA can be useful in establishing one's ancestry, I decided to write this article.

Summary and conclusion: In conclusion, what I am postulating is that any male who is properly tested and finds he belongs in haplogroup R1a1, is a direct descendant of Adam. I feel strongly about this, but again, can not conclusively prove it. So, if you are like me in that you feel as though you are a part of the Adamic Race, you now have at your disposal a tool in the form of genetic testing that may help you to understand better whether or not you are. In other words, you can now find out with absolute certainty which haplogroup you are a part of.
