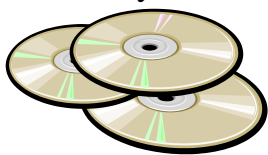

I want to begin by sharing this wonderful Bible truth contained in these verses from the Prophet Jeremiah.

Jeremiah 17:7-10

7 Blessed is the man that trusteth in the LORD, and whose hope the LORD is.

THE GENERATIONS OF ADAM

(An elective, free to accept, or reject Bible study)

GENESIS 5:1 *“THIS IS THE BOOK OF THE GENERATIONS OF ADAM. IN THE DAY THAT GOD CREATED MAN, IN THE LIKENESS OF GOD MADE HE HIM.”*

Please do not miss the importance of the above verse and our heading for this particular study from **Genesis 5:1**. *“This is the Book of the generations of Adam,”* literally means, *“This is the Book of the race of Adam”* (Note, it is not just the book of **Genesis**, but applicable to the whole book of the Adamic-Israel Christian Bible, both Old and New Testaments, or the Covenants). The Adamic people, and the seed of Abraham, Isaac, and Jacob (Israel) are of the same kindred genetic lineage. As I previously said, **RACE MATTERS**.

I realize in today's politically-correct thinking, that race, especially the White Caucasian race, is to be shamed and looked down upon. Though, I would certainly agree that “race” can be improperly embellished and puffed up, we also need to understand that our White ancestry can, has, and is, purposefully being undervalued, Biblically unappreciated, and even thought of as unworthy in comparison to the other races. I for one want to do everything in my power, with the help of God Almighty, to urge on and support my racial Adamic Israelite kinsmen according to the flesh by the leading and power of the Holy Spirit.

I'm sure that the following article about Adam will move you to be spiritually stirred and fascinated with new Biblical insight. I must state at the beginning that it is to a large degree, that because I am aware of the many shortcomings, moral failures, and stiff-necked ways of our racial kinsmen that I readily advocate that we all uphold a strong

sense of racial support with a Biblical Christ-centered objective and purpose. Certainly we must remember what the Lord Jesus Christ admonished His Kingdom people in **Matthew 12:25**, “*...Every kingdom divided against itself is brought to desolation; and every city or house divided against itself shall not stand.*”

Nothing divides God's people more than Biblical and racial ignorance. There's a big difference in being a believer who reads the Bible and being a believer who reads the Bible as a Berean. In fact, a person can be a student of the Bible, read it every day, and yet be spiritually naïve, and “wet behind the ears.” They can go to their Judeo-Christian church regularly, and yet, also be highly multicultural and racially indifferent. If we are spiritually and racially divided, mixed and amalgamated, we are sucked into a worm hole of relativity and corruption that cannot be corrected without finite principles of Biblically directed righteousness. Can you not hear the creation crying out for the sons of God to be revealed?

Romans 8:16-19

¹⁶ The Spirit itself beareth witness with our spirit, that we are the children of God:

¹⁷ And if children, then heirs; heirs of God, and joint-heirs with Christ; if so be that we suffer with him, that we may be also glorified together.

¹⁸ For I reckon that the sufferings of this present time are not worthy to be compared with the glory which shall be revealed in us.

¹⁹ For the earnest expectation of the creature waiteth for the manifestation of the sons of God.

The Adamic Israelite sons of God cannot, and will not be revealed in racial mongrelization, nor will race in and by itself reveal the heirs of the promise. What must be merged, and

what will make the blessed difference is the Holy Spirit merging with God's Covenant people. ***“The Spirit itself beareth witness with our spirit, that we are the children of God.”*** It is the Holy Spirit's desire that God's Covenant people be brought together in the bonds of the New Covenant. The Lord Jesus Christ in **Hebrews 8:8-10**, is certainly not speaking of a racially blended New Covenant Israel, though Spiritual Israel (race doesn't matter) advocates promote such in their teaching.

God will do what He has purposed to do with Israel. **His plan A is still “plan A,”** meaning, God Almighty did not relegate away what He has Covenanted to do with His Abrahamic Covenant people. Both the Old Covenant and the New Covenant, including the glorious Kingdom to come, is part of God's great plan of the Ages.

The first Adam's fall was part of **Plan A**, and likewise, the sacrificial death of our Redeemer and Savior, Jesus Christ, the Last Adam, was part of this same **Divine Plan**. When Jesus said, ***“...I am not sent but unto the lost sheep of the house of Israel”*** (**Matthew 15:24**), He meant it. **Plan A** is to bring Israel, the whole House of all 13 tribes, which included Ephraim and Manasseh into New Covenant relationship with Himself (Jesus Christ, God in the flesh, who came in the form of Judah-Israel-Adamic-Man, our sinless Kinsman Redeemer). **Plan A** began with the fall of the first Adam, and it includes the Redemption of Adamic man. The Abrahamic Covenant provided for a blessed Redemption and Salvation through which Jesus Christ, the Creator of all things has purposed to do.

One of His profound, glorious purposes is found in: **1 Corinthians 15:22**, ***“For as in Adam all (Adamites) die, so in Christ all (Adamites) will be made alive.”*** It begins with the fall of Adam, and it is finished with the **REDEMPTION OF ADAMIC-ISRAEL-MANKIND** by our

blessed Redeemer, **Jesus Christ**, the last Adam.

Deuteronomy 32:8-9

⁸ When the most High divided to the nations their inheritance, when he separated the sons of Adam, he set the bounds of the people according to the number of the children of Israel.

⁹ For the LORD's portion is his people; Jacob is the lot of his inheritance.

Why would God Almighty ***“separate the sons of Adam”*** and then ***“set the bounds of the people according to the number of the children of Israel”***? What might this mean? Does this mean that the sons of Adam are without hope? To the contrary, these verses are of a greater Covenant of Hope through the Jacob (Israel) people, the lot of His inheritance, for the restoration of Adam kind (remember, Adamites and Israelites are of the same racial genetic descent). Under Adam's fall, sin came upon all the seed of Adam, **(death was already upon the pre-Adamic creation, carbon testing, and other forms of testing show death long before Adam)**. Adamic man was a new creation, but the question is, which creation, the sixth-day Adam man of **Genesis 1:26-28**, or the eighth-day Adam of **Genesis 2:7**?

I believe there is Biblical evidence that there was an eighth-day Adam (man) who was created under different conditions than the sixth-day Adam (man) of Genesis 1. For instance, there was no Garden of Eden created for the sixth day Adam-man people. In fact, **Genesis 2:4-5**, makes it clear that ***“...there was not a man to till the ground”***:

⁴ These are the generations of the heavens and of the earth when they were created, in the day that the LORD God made the earth and the heavens,

⁵ And every plant of the field before it was in the

*earth, and every herb of the field before it grew: for the LORD God had not caused it to rain upon the earth, **and there was not a man to till the ground.***

Notice, prior to chapter 2, “***...there was NOT a man to till the ground.***” This would seem to indicate that “man” described in chapter one, was more of a “hunter, gatherer” type (though, not necessarily, exclusively) than an agrarian farmer type of “man.” The Adam of chapter 2 seems to display a higher understanding of God’s order and harmony of life. He names all the living creatures in verses 19-20, as you read through the chapter, Adam is able to openly communicate with God Almighty. There is enough evidence given that convinces me that Adam is clearly of a higher order. This does not mean that the previously created “pre-Adam man” (of the old world) was without intelligence, for ancient historical findings surely reveal that there were several highly advanced civilizations that go back many thousands of years before Adam. The evidence will show that there were Aryan type advanced civilizations.

There were old Aryan colonies from the ninth to fifth centuries BC. Historical researchers have estimated older regions of Aryan Civilizations in the near East, from Asia Minor, Mesopotamia, and Syria-Phoenicia were at one time, a highly advanced bastion of Civilization. Included in this civilization, would also be the Chinese. The main problem with all these pre-Adam Civilizations is that they were paganized, morally corrupt, and prone to self-destruction. (Sounds like America today.)

Also included in the pre-Adam people are the black, or colored races which include the Negroes, Hottentots, Bushmen, Papuans, and other such kind. Their skin color ranges from dark chocolate color to blue-black. They, among their own kind, without the influence of the White race, have only been a semi-civilized people. But let us get

back to **Genesis 2**. Please notice the order of things in the following verses.

Genesis 2:7-9

⁷ And the LORD God formed man of the dust of the ground, and breathed into his nostrils the breath of life; and man became a living soul.

⁸ And the LORD God planted a garden eastward in Eden; and there he put the man whom he had formed.

⁹ And out of the ground made the LORD God to grow every tree that is pleasant to the sight, and good for food; the tree of life also in the midst of the garden, and the tree of knowledge of good and evil.

First we are told in **verse 7**, that God ***“formed man of the dust of the ground, and breathed into his nostrils the breath (Holy Spirit Intelligence) of life.”*** Then in verse 8 we read, ***“And the Lord God planted a garden east-ward in Eden.”*** It would appear that Adam was formed first, and then, he was placed in the newly created garden. His Adamic realm was to be within the Garden of Eden at this stage of his “pre-fallen” existence. Then we have **verse 9**, which is quite a verse and all I will say at this time, is that this is obviously quite a Garden and there is much that Adam will have to deal with in this Garden. This scenario is quite different from the “man” of Genesis 1.

As many of you are aware, the fall of the eighth-day Adam generated death upon all future seed of the White Adamic people. Again, death was already upon the pre-Adam creation of **Genesis 1**, but let’s take a little time and explore this ancient family of Adam. In previous studies I have presented evidence that ***“Adam”*** means ***“of ruddy complexion, to blush, or show red in the face,”*** a main characteristic of White Caucasian people. This definition

and description applies to “*man*” in both **Genesis 1 and 2**.

UNFOLDING THE ADAM MYSTERY

I will begin with this brief explanation. First, when I am referring to “pre-Adamites,” I am referring to those created prior to the eighth day Adam of **Genesis 2**. We Kingdom Adamic-Israel believers do not believe that all races came from Adam and Eve, as this would involve an unBiblical evolutionary process. We believe in the Biblical kind after kind genetic offspring Divine arrangement, and we believe that Adam-man-kind is of the White Caucasian genre. There was a pre-Adamic creation (the old world age), followed by the Age of Adamic Israel, and the Kingdom Age to come.

Some of the things I am about to share with you are clearly elective (open for discussion and further investigation) issues about Adam, some of which, I freely admit, I cannot fully prove, but to believe that all races came from Adam and Eve is clearly an evolutionary falsehood. I really believe, after much study and consideration of these beginning chapters of **Genesis**, that most likely within any of the various theories of what actually took place in these opening chapters, a variety of gaps could be found.

I do know for certain, that God Almighty supplies the main issues and topics with His Word that He wants us to believe and focus upon. What He does not reveal or unfold within His Word, can often be understood by what He reveals, or even from what He does not reveal, which affords believers certain freedoms in our Berean study. I do believe though, that I can present a Biblically logical explanation of Adam that is in keeping with the overall Will, Plan, and Purposes of God’s Word to His Covenant Adamic-Israel people. Although it is not necessary to have a full understanding of the creation process in **Genesis** it nevertheless helps to

increase one's understanding of the complete Word of God. It is my opinion that **Genesis** is the foundation that pretty much underpins the rest of Scriptures.

WHO IS THE CREATED “MAN” OF GENESIS 1?

Let's begin with **Genesis 1:26-27**.

²⁶ *And God said, **Let us make man in our image, after our likeness:** and let them have dominion over the fish of the sea, and over the fowl of the air, and over the cattle, and over all the earth, and over every creeping thing that creepeth upon the earth.*

²⁷ *So God created man in his own image, in the image of God created he him; male and female created he them.*

Who is this “man” that God said “**Let us make man in our image, after our likeness**”? Also, who is God referring to when He states, “**Let us make man in our image**”? Who does “us” refer to? I believe the answer to this question is found in the following verse of Scripture:

2 Corinthians 5:19

¹⁹ *To wit, that **God was in Christ, reconciling the world unto himself,** not imputing their trespasses unto them; and hath committed unto us the word of reconciliation.*

The explanation to the meaning of “us” in **verse 26** is, “**God was in Christ.**” The Mystery of the Godhead concerning “**Christ in you the hope of glory**” (**Colossians 1:27**), is very much akin to what we are learning in **Genesis 1:26**. God was in Christ, and it was in this image that He created “man.” The question remains, who is this “man” referred to in **Genesis 1:26**?

Is this “*man*” (in **Genesis 1:26-27**) a reference to all the various races of people who existed prior to the Adam created in **Genesis 2:7**? Many believe that “*man*” created in Genesis 1 is different from the Adam man of Genesis 2. It can be quite confusing as I’m sure many of you are already aware. Of course, to the Judeo-Christian who believes all races came from the magical sperm of Adam, making Adam and Eve the father and mother of all races, they would of course believe this Bible study to be highly unBiblical. But we must be Bereans of the Word in faith. Bereans who have every Biblical right and freedom to think, reason, and research, with the Light and guidance of the Holy Spirit unto the blessed Truth.

Genesis 2:7-8

⁷ And the LORD God formed man of the dust of the ground, and breathed into his nostrils the breath of life; and man became a living soul.

⁸ And the LORD God planted a garden eastward in Eden; and there he put the man whom he had formed.

Later in Genesis (**Genesis 3:19 & 20**), man is identified as “*ADAM*.” But, here in **Genesis 2:7-8**, we have two main Bible passages using the term “*man*,” but where does this lead us in our study? First, let me point out that the terms “*man*” and “*Adam*” used in the book of **Genesis** are one and the same in meaning, but not necessarily in who they were created to be. They both come from Strong’s Concordance Hebrew word “*aw-dawm*,” number 120, also referencing number 119. The Scripture verses that describe them, are quite different. As an example, **Genesis 1:26-28** does tell us that “*man*,” who again appears to poses the same racial characteristics and “*aw-dawm*” identity, was clearly created on the “*SIXTH DAY*.”

In other words, the “*man*” (male and female *-aw-dawm*)

created on the sixth day (**Genesis 1:26**), were most likely, White pre-Adamites who existed long before the eighth day created Adam of **Genesis 2**. The Adam of **Genesis 2** was of a higher order of creation, and intelligence (from the definition of God breathed in Adam's nostrils) than those White pre-Adamites of the first chapter. The Adam of **Genesis 2** was created qualified, even certified as a *"son of God"* in the Biblical sense and meaning of this term.

Proof of this, I believe can be found in the fact that in **Genesis 2:7**, this Adam was *"formed of the dust of the ground, and (God) breathed into his nostrils the BREATH OF LIFE, and man became a living soul."* The *"man"* (aw-dawm) of **Genesis 1:26** is **NOT** described as being made with this **BREATH OF LIFE** creation process. It says, *"And God said, let us make man in our image, and after our likeness: and let them have dominion..."* Yes, there are similarities in the Adam of **Genesis 2** and **Genesis 1**, but again, could it be that the Adam of **Genesis 2**, is of an eighth-day creation, while the Adam of **Genesis 1** is of a sixth-day creation? In the description of the Adam of **Genesis 2**, could it be that God **breathing the BREATH OF LIFE** into him is representative of a **Holy Spirit feature** or quality that the Adam man of **Genesis 1** did not possess?

I must caution, though they may be of the same race, meaning racially White and of ruddy complexion, this does not necessarily mean that both are one and the same individual, with the same calling and purpose. You see, I believe that the Adam of **Genesis 1**, is referring to pre-Adamic White people, and that the Adam of **Genesis 2**, is of a higher order, calling, and purpose, though both Adams are racially White and of a ruddy complexion. It is indeed the book of the generations of Adam, and hopefully, this study will help clear up gray areas of uncertainty.

By the way, the phrase *“male and female created He them,”* simply means that God created both the male and the female gender for the procreation of their race. In **Genesis 7:3**, we find the obvious purpose of male and female, is to *“keep seed alive upon all the face of the earth.”* All people, *“male and female”* God created them, BUT, only of the order of Adam-kind, did God issue the order of *“subdue the earth and have dominion.”* This emphasis upon *“man”* in **Genesis 1:26-27**, is upon a particular, man, Adam-kind man, meaning white people who bear the racial marks or genetic category (meaning they were also of a ruddy complexion) as the Adam of **Genesis 2:7-8**.

They are both *“aw-dawm”* (Adam creations), which does not necessarily mean that they are one and the same. I believe that the Adam man of the **Genesis 1** stands out above the other pre-Adamic people, in that these chapter one Adamites were given a dominion calling long before the Adam of **Genesis 2** appeared. They were of the Old World. How “old” we do not know, but **2 Peter 2:4-5**, speaks of this old world and that *“God spared not the angels that sinned.”* However, the word *“angel”* means messengers, and most likely has little to do with winged creatures that most people think of concerning *“angels.”* If you were to read on in **2 Peter 2:5**, you would discover that Noah is described as a *“preacher of righteousness.”* I believe these ancient Adamites were given a duty to minister as *“messengers,”* or *“angels”* of righteousness. To take *“dominion”* and lead this creation forth in righteousness, but they failed, and were in a “fallen” state when God brought forth *“ADAM”* of **Genesis 2**.

Please understand that I am not being dogmatic about this or insistent that we must all agree with my perspective on Adam, but we do have the freedom to think, question,

and seek to learn new and greater Biblical truths do we not? I think many of you are like me, in that you have wondered about the Adamic order of creation. You have wondered where Cain, Seth, and other Adamites got their wives, and so forth. It has never made sense to me that if all the pre-Adamites were only dark-skinned people, then we are simply left with the fact that either the Adamites got their wives or husbands from these pre-Adamite colored races, or the Adam sons and daughters married each other, It makes much more sense that there were White pre-Adamites.

I have also wondered about **Genesis 6:2**, when *“the sons of God saw the daughters of men,”* and what this might mean? I knew that the *“sons of God”* were not fallen angels as some has supposed. Let’s look at these verses:

Genesis 6:1-8

¹ And it came to pass, when men began to multiply on the face of the earth, and daughters were born unto them, [Please note that the word *“men”* is also #120 in the Strong’s Concordance and it means “aw-dawm,” meaning, these *“men”* were White people, White Adamites, I believe of Genesis 1 extract].

² That the sons of God saw the daughters of men that they were fair; and they took them wives of all which they chose.

First of all, *“the sons of God”* literally means *“the son of the family of God.”* It is a family name. The *“sons of God,”* I believe refers to those Adamites of **Genesis 2**, who looked upon the White pre-Adamites of **Genesis 1**. It is important to note that the White pre-Adamites of **Genesis 1**, were morally corrupted, and mostly into paganism and idolatry. So when the *“sons of God”* mingled with these paganized Adamites of **Genesis 1**, it spelled disaster is about to happen, as the following verses clearly describe.

³ And the LORD said, My spirit shall not always strive with man, for that he also is flesh: yet his days shall be an hundred and twenty years.

⁴ There were giants in the earth in those days; and also after that, when the sons of God came in unto the daughters of men, and they bare children to them, the same became mighty men which were of old, men of renown.

Again, I must point out that there are two type of people who make up the “*sons of God*,” and “*men*,” or in this case, the daughters of men. Both are “*aw-dawn*,” meaning they are both DNA genetically White and are able to blush and show blood in the face, but, clearly not of the same class or order. Concerning the “*giants in the earth*,” I shall not get into this subject at this time. Some believe them to be “*angels*,” all I will say is that I am highly skeptical of this perspective. But we must move on with our main topic.

⁵ And GOD saw that the wickedness of man was great in the earth, and that every imagination of the thoughts of his heart was only evil continually. [I believe the “wickedness of man” is speaking of Adam kind (both Adams).]

⁶ And it repented the LORD that he had made man on the earth, and it grieved him at his heart.

⁷ And the LORD said, I will destroy man whom I have created from the face of the earth; both man, and beast, and the creeping thing, and the fowls of the air; for it repenteth me that I have made them.

⁸ But Noah found grace in the eyes of the LORD.

⁹ These are the generations of Noah: Noah was a just man and perfect in his generations, and Noah walked with God.

Please notice in **verse 8**, “*But Noah found grace in*

the eyes of the Lord,” just like “Abraham also found “grace” in the eyes of the Lord. Noah, like Abraham was one of many Adamites who “spiritually and racially distinguished themselves,” in that they did not pollute themselves genetically, or spiritually. When we read, *“Noah was a just man and perfect in his generations,”* and *“Noah walked with God”* (**Genesis 6:9**), this word *“perfect in his generations”* is in reference to being racially pure, and it means “without blemish, and undefiled,” in his generations “descent, or family.”

Spiritual Israel teachers will do everything in their power to convince their followers that race is not important, by saying, “none of us can prove that we are racially pure” (what they don’t say is that you can’t prove that you are racially pure) in an effort to move people away from following the path of preserving our God given racial integrity for the preservation of our Adam, Shem, Noah, Abraham, Isaac, and Jacob Biblical Covenant Heritage. **This is a spurious argument** because if God was using a people and He told them to remain separate, He would make sure that they did exactly that. It was His job to keep a racial pure people to fulfill His Promises. If all races are mixed up, we would not have the diversity that God created and called good!

Jesus said, *“My sheep hear my voice.”* **John 10:27.** So, if we hear His voice, especially on who true Israel really is, then most likely they are genetic Israel. Point being, if God said there would be a people of His Covenant preserved, then there will be such a people. Why is it that throughout History, has Christianity been known as the White Man’s religion?

THE LINK BETWEEN GRACE AND RACE

Another spurious argument given by Spiritual Israel teachers is that we believe we are saved by race.

Obviously, we are saved by grace and grace alone, (**Acts 15:11; Ephesians 2:5, 8; 2 Timothy 1:9**) but there is a definite Biblical link between “grace and race.” Perverting or adulterating race does not invite more of God’s Grace, which indeed is unmerited favor. God’s Grace, or, unmerited favor, is not based upon sin abounding in our life, but upon the righteousness of Christ growing in our life. Meaning, if Grace is to abound, it is to abound towards our growing in righteousness of Christ. As the Apostle Paul explains:

Romans 5:20-21

²⁰ Moreover the law entered, that the offence might abound. But where sin abounded, grace did much more abound:

²¹ That as sin hath reigned unto death, even so might grace reign through righteousness unto eternal life by Jesus Christ our Lord.

Romans 6:1

What shall we say then? Shall we continue in sin, that grace may abound?

Sin, or offense abounds we are told, because of the law, well, Grace abounds because of the righteousness of Christ. In other words, Grace is a blessing that grows because the Righteousness of Christ abounds.

There is a New Covenant of Grace upon Israel, or, an imputed Grace upon Adamic-Israel that is of God, not man. Meaning, Israel has a racial identity that was Divinely selected, created, and Covenanted with and that merges both race and grace within the bonds of the New Covenant that is directed to the whole National House of Israel. Abraham did not choose God’s Covenant upon him and his descendants through Isaac, and Jacob. That Covenant was God given and not based upon the words, actions, or righteousness of Abraham. The Abrahamic Covenant was

based solely upon the Sovereign Word of God. The New Covenant exudes, radiates, displays, unmerited Grace or favor upon the physical, genetic, kindred of Abraham, Isaac, and Jacob. So, yes, there is a link between “grace and race.”

WHERE DID ADAM’S CHILDREN GET THEIR WIVES OR HUSBANDS?

I believe that Adam’s children got their wives, and or even husbands as the case may be, from preexisting **Genesis 1** White preAdamites. Certainly, all the various colored races are pre-Adamic, and they date back well beyond the six thousand years of the Adam of **Genesis 2**. It is also true that there were highly advanced ancient White civilizations. The Egyptians alone, who clearly, as recent research has proven, had White DNA, existed prior to the Adam of **Genesis 2**. There have been many civilizations much older than the 6,000 year theory. Archaeologists continue to find lost civilizations that were much more advanced than just hunters and gatherers. Also, consider that time for Adam probably did not begin until the Fall.

We know that Adam’s son Cain, according to **Genesis 4**, murdered his brother Able, and God drove Cain away from *“the face of the earth,”* meaning God drove Cain out of the Garden to the East. As you will read in the following verses, Cain was very concerned that God would treat him as a *“fugitive,”* and cast him out of the *“earth”* (I believe this means, out of the Adamic earth or garden); it obviously does not mean the whole earth. Therefore, God put a *“mark upon Cain, lest any finding him should kill him.”* Understand this, God was not protecting Cain because he was the son (as the Babylonian Talmud teaches) of some devil fathered child with Eve, as the dual seed-line teaching goes, but God was protecting Cain because he was a proper son of God, though of a fallen

nature. **Genesis 4:1** tells us clearly, *“**And Adam** [NOT THE DEVIL] **knew Eve his wife; and she conceived, and bare Cain, and said, I have gotten a man from the Lord.**”* So, when God expresses His willingness to provide protection for Cain in the following verses, He is not doing so because Cain is the offspring of the devil, but because Cain is a son of God, though clearly he has committed a wrong in the eyes of God.

Genesis 4:14-16

¹⁴ Behold, thou hast driven me out this day from the face of the earth; and from thy face shall I be hid; and I shall be a fugitive and a vagabond in the earth; and it shall come to pass, that every one that findeth me shall slay me.

¹⁵ And the LORD SAID unto him, Therefore whosoever slayeth Cain, vengeance shall be taken on him sevenfold. And the LORD SET a mark upon Cain, lest any finding him should kill him.

¹⁶ And Cain went out from the presence of the LORD, and dwelt in the land of Nod [it simply means, the land of exile], on the east of Eden.

¹⁷ And Cain knew his wife; and she conceived, and bare Enoch: and he builded a city, and called the name of the city, after the name of his son, Enoch.

According to **Genesis 4:16-17**, Cain *“**...went out from the presence of the Lord, and dwelt in the land of Nod, on the east of Eden. And Cain knew his wife; and she conceived, and bare Enoch: and he builded a city.**”* Well, this presents several questions that need to be considered.

- 1) Where did Cain get or find his wife, if all people and races came from Adam and Eve? The obvious answer, of course, is that not all people and races

came from Adam and Eve. There were pre-Adamites, which included White DNA people, as well as the other various races of people. There were ancient pre-Adamite family dynasties already in existence of the old world, and it is from one of these pre-Adamite families that Cain found his wife. What race his wife was of, we do not know with any certainty.

- 2) Indeed, Cain was of the *“wicked one,”* in that he was a follower of the serpent beguiler (obviously a man, a cunning deceiver, who was sent, [by God, not the “devil,” because **God IS Sovereign**, He was not out of the picture; it was His picture, His Plan] meaning, God allowed this cunning deceiver to pervert the carnal minds [which is enmity with God] of Adam and Eve). The fall of Adam and Eve was part of God’s Divine Plan of the Ages. I believe the *“knowledge of good and evil”* (that God has forbidden Adam and Eve to partake of), was somehow embraced by Cain. He partook of this forbidden knowledge, and with this corrupt Kabala knowledge (literally the Kabala is the ancient oral traditions of the elders of pagan cultures) was deceived into believing that his sacrifice before God would make him as a god, knowing good and evil. It was also this perverted Kabala knowledge from which most of the later Babylonian Talmud was extracted.
- 3) Why was Cain, in **verse 14**, so afraid *“that every one that findeth me shall slay me”*, if it was only Adam, Eve, and Cain for the most part? Obviously there were, from the context of that verse, many other people on earth, meaning vast populations of pre-Adamite people. Also, Cain in **verse 17**, *“builded a city.”* This word *“city”*

could also mean “town or post”, but clearly it was a place for growth, that others of his kind or persuasion would be permitted to come and live within.

- 4) The same question applies to the other offspring of Adam and Eve. Where did Seth and the other sons and daughters of Adam get their wives and husbands? The same Judeo-Christian Bible authorities, who tell us that all races came from Adam and Eve, also tell us that Cain, Seth, and the other children of Adam must have married one of their brothers or sisters. This violates Bible law, and if this practice is forbidden by God according to **Leviticus 18:9-18** or **Leviticus 20:17**, it stands to reason that He would not have sanctioned such unions among Adamic siblings. The Adamic sons of God were not a primitive, aboriginal, ignorant people.

If Adam had not sinned, or transgressed God's Divine directives, Adam and his descendants would have been able to proceed in Life, instead, they died under the law, for without the law, there can be no transgression or sin. It is also likely Adam and Eve had to disobey (sin and be in a fallen state) before they could have children as we do not see any children born before the fall. The fall was part of God's sovereign plan.

Also, this transgression, or sin “*separated the sons of Adam,*” in that most of them became morally corrupt and pagan. God Almighty eventually set His eyes upon faithful Abraham, and He Covenanted with him and his seed through Isaac, and Jacob to be His Covenant people, “*the lot of His inheritance.*” Through a Divine selective process, God Almighty blessed the seed of Israel to be as the “*sand of the sea, and stars of the heaven,*” and He

eventually brought the sons of Adam (who were not Israelites, although, they were White DNA racial kindred strangers) into the ***“bounds of the (Israel) people (according to their number).”*** Meaning, it was in God’s Divine Plan to assimilate the seed of Adam into His Jacob Israel People. ***“When He separated the sons of Adam, He set the bounds of the people according to the number of the children of Israel.”***

But **Plan A** does not stop here, it continues with a great work of redemption for fallen Adamic Israel. We read in **Deuteronomy 30:6**, ***“And the Lord thy God will circumcise thine heart, and the heart of thy seed, to love the Lord thy God with all thine heart, and with all thy soul, that thou mayest live.”*** The term *“seed”* means descendants, not *“spiritual seed”* but physical seed of the children of Israel, and those racial kindred Adamic strangers who would attach themselves unto the seed of Abraham, Isaac, and Jacob. The Old Covenant was insufficient for the Holy Spirit process of heart circumcision. **Jeremiah 31:33** states, ***“...After those days, saith the Lord, I will put my law in their inward parts, and write it in their hearts.”*** This is the New Covenant promised, through which Jesus, by the power of the Holy Spirit will change our carnal minds (or heart), and infuse us with a Christ nature and character after the Spirit and His Righteousness.

Hebrews 9:15

*And for this cause he (Jesus) is the mediator of the new testament, that by means of death, for the redemption of the transgressions that were under the first testament, **they which are called** (ISRAEL, were the people called) *might receive the promise of eternal inheritance.**

Jesus death on the cross brought the Old Covenant to an end, but at the same time, He officially inaugurated the New

Covenant by His sinless sacrifice.

The Bible is the announcement of Adamic man and God's calling and purposes for Adam kind. As I stated previously, death was already upon the pre-Adamic creation. Adam and Eve did not know death until they fell in sin, and became part of the fallen creation. Both Adamic and pre-Adamic creation now share in the pains of death. All were lost and without hope. All needed a Savior, they needed to be saved from death. This was God's Plan all along and we know that because Jesus was the Lamb slain **before** the foundation of the world. Why would He be slain before the foundation of the world except that God knew and planned Adam's Fall?

The pre-Adamite people are with us today, and both the Adamic people and the pre-Adamic people are in need of deliverance, because the first Adam could no more deliver his kind or kinsmen than the pre-Adamites could their kind. God could certainly have prevented the pre-Adamic people from becoming part of this Adamic Order of the Ages, but He obviously included them. Their existence was transferred into this present Age. Both pre-Adamic and Adam-kind were and are in need of a Savior.

FINAL THOUGHTS

Obviously, this study could be stretched out further. As I see it, the main questions are:

- 1) Were Adam and Eve the first people God created?**
- 2) Were there other people in existence prior to Adam and Eve?**
- 3) Does Genesis chapters one and two only refer to the creation of only one set of Adams, meaning, Adam and Eve? Or could these two chapters involve other creations of "man" outside of Adam and Eve?**

Has this Bible study on Adam answered all of our questions? To the contrary, it has most likely created many more questions. I am hopeful though, that this study will lead us to deeper and greater Biblical truths. Though God Almighty did not provide a full detailed explanation of what happened in the creation process of **Genesis**, it does not mean that He wants us to turn off our brain and think no further than the few details He has provided in His blessed Word. We must always remember that His Word is **REVELATORY!**

Israel has Changed the World!

*But ye shall receive power, after that the Holy Ghost is come upon you: and ye shall be witnesses unto me both in Jerusalem, and in all Judaea, and in Samaria, and unto the **uttermost** part of the earth. Acts 1:8*

In the last two issues of the magazine, **Christianity Today** there have been two amazing articles which prove to the discerning person, that the White Anglo Saxon Germanic and kindred peoples are fulfilling the verse above. The first article is titled, ***The Surprising Discovery about Those Colonialist, Proselytizing Missionaries*** (They didn't set out to change history. But one modern scholar's research shows they did just that!) by Andrea Palpant Dilley/ January 8, 2014.

In this article, the author reports on Robert Woodberry who was challenged to study out the effects of missionaries on the world by a lecture given by Kenneth A. Bollen. "Bollen remarked that he kept finding a significant statistical link between democracy and Protestantism. Someone needed to study the reason for the link." Robert Woodberry took up that challenge and spent 14 years researching even received a half million dollar grant to do the work. He summed up his research this way:

"Areas where Protestant missionaries had a significant presence in the past are on average more economically developed today, with comparatively better health, lower infant mortality, lower corruption, greater literacy, higher educational attainment (especially for women), and more robust membership in nongovernmental associations."

The author of the article summed it up this way:

"In short: Want a blossoming democracy today? The solution is simple—if you have a time machine: Send

a 19th-century missionary."

Another very important fact was uncovered by Woodberry.

"The positive effect of missionaries on democracy applies only to 'conversionary Protestants.' Protestant clergy financed by the state, as well as Catholic missionaries prior to the 1960s, had no comparable effect in the areas where they worked. Independence from state control made a big difference. 'One of the main stereotypes about missions is that they were closely connected to colonialism,' says Woodberry. 'But Protestant missionaries not funded by the state were regularly very critical of colonialism.'

In the February 2014 issue of *Christianity Today*, they have another article on missionaries written by a native Indian author titled, *How White Missionaries Helped Birth Modern-Day India*. In this article, the author and the Christian from India that he interviews show that when the British came to India there were 70 major Kingdoms warring with each other, 450 languages, and horrible practices such as burning a man's wives alive with his dead body, the caste system, and illiteracy was rampant.

The **white** missionaries learned the languages in order to translate the Bible into their languages. They codified the languages and reduced them to four major ones. The missionaries who were independent of the British Government transformed the country into a unified India. Amazingly, even with the British leaving in 1947, there have been no military coups and they have had free and fair elections even today. So there is a lasting effect from the missionary efforts of over 70 years ago because they used the principles of God!

The missionaries actually Christianized Hinduism. What I mean by that is they caused the Hindus to abolish their worst practices. Because the Christians spoke out against the burning of wives, temple prostitution, and the caste system, Hinduism changed. As the author states, "Indian Christians have forgotten the impact their [White] missionary forefathers had, on language, education, Indian identity, health, and the treatment of women, outcasts, the poor." What the author doesn't say is that for the last 50 years the enemies of Christ have taken this information out of our history textbooks and we have only heard of the atrocities committed by governments and state support missionary groups. Also, even ignored by the author of this article is that these transformers of the Indian world were **WHITE**. This information has been forgotten not just by Indian Christians, but by the Israelite nations of the world. They fulfilled the admonition to go to the uttermost parts of the earth and amazing change took place when they followed His Principles and were not just an arm of the Government!

The author also states, "One aspect of what I do is to encourage Christians: 'Look, you have a great heritage.' Our forbearers invested in the future of the country. We should stop complaining and living in fear, and instead contribute like they did to building the nation....Before, many Indian leaders were Christianized. Nehru was a Christianized agnostic. Gandhi was a Christianized Hindu. That is going away. After 60 years, leaders of integrity are gradually disappearing." We see the same results in America where we have forgotten our Christian principles. So before we can be a force for good in other parts of the world, we need to truly work for a revival of Christianity within the Anglo-Saxon people and an awareness that they are the literal, physical, Children of Israel who are to be **His Witnesses! SAFE Act Proponent Charged for Carrying Gun on Campus

On February 6th, peace activist and SAFE Act gun control proponent Dwayne Ferguson was arrested with a gun on his person at Buffalo, New York's Harvey Austin Elementary School.

Friends have rallied to his side to say he ought not face the SAFE Act felony charges he supported for everyone else because it was "an honest mistake."

[According to The Buffalo News](#), 52-year old Ferguson said he "frequently carries the gun, for which he has a permit" and that he went to the school as part of a mentoring program, without even thinking about the gun being on his person.

The school received a call that a man with a gun was on campus about 4:15 PM. Thereafter, those on campus for afterschool programs were placed on lock-down. Ferguson called a Buffalo police lieutenant to ask why the school was locked down and was told a gunman had been reported on campus.

Supporter Rev. James E. Giles said Ferguson then led about 50 kids "into the cafeteria and closed the doors" to keep them safe. President of Buffalo United Front, George Johnson, added, "[Ferguson] probably was in a position to help the police not knowing that he was the one they were looking for." Ferguson was charged with "two counts of criminal possession of a weapon" under SAFE Act provisions.
